DIRECTORS' REPORT

for the financial year ended 31 December 2022

The directors present their report and the audited financial statements for the financial year ended 31 December 2022.

Principal Activity and Review of the Business

The principal activity of the company is to promote recognition, run projects and represent the interests of the Travelling Community.

The Company is limited by guarantee not having a share capital.

In its mission statement, TVG is defined as an independent, Cork-based, Traveller-led community development organisation. TVG will pursue social justice and equality with Travellers so that we can live free from racism and discrimination.

The following are the values and principles that underpin the TVG strategy and its work:

- TVG is an open and welcoming space for all Travellers and promotes Traveller visibility across Cork;
- TVG continually promotes Traveller participation and Traveller leadership;
- TVG works from a human rights and anti-racist perspective and will be Traveller-led;
- TVG promotes Traveller ethnicity and Traveller identities;
- TVG is committed to collective action with the Traveller community and works in solidarity with wider society to create a better Ireland.

The Directors are pleased that substantial work has been completed during 2022 in relation to each of these objectives.

2022 saw the welcome return to in-office work and a slow easing of Covid 19 pandemic restrictions over the year. The team were able to return to a blended working environment in the second quarter of 2022 splitting their work schedule between remote and on-site locations. We also started to work with our established Traveller women and men's group after the summer. This was a challenge as many people had been impacted by the Covid 19 restrictions and it took some time for people to get used to in-person events, coming out of the restrictions and building up trust and engagement again. However, the team were mindful to ensure best health and safety practices were in place at in-person events to mitigate the risk of Covid 19 cases. By the end of 2022 all existing groups were back up and running well, with some new groups starting up too which was encouraging. A particular development was the creation of groups for younger Traveller men and women (16+) who were interested in gaining professional training for career progression and in 2022 a number of construction skills training events have taken place with more planned for 2023.

2022 also saw the return of in-person campaign work and TVG workers represented Travellers in Cork at the national housing crisis protest "Raise the Roof" in Dublin along with a national campaign calling for support and government intervention into the Traveller mental health crisis. It was a shame to note that no government leader met with the group at the protest outside Leinster House on the day of the well advertised campaign.

The 2022 Traveller Pride celebrations were well attended and the Family Fun Day in Fitzgerald's Park was a particular success in collaboration with the Cork Traveller Women's Network, a day of learning and celebrating Traveller culture mixed with family friendly events for Traveller families and settled people alike to enjoy all in the spirit of celebration Traveller identity in the city.

The NTRIS STAR Education pilot continued to work with schools, students and their families to find better working models and highlight challenges that from barriers to better outcomes for Travellers in education. The team are focusing on building a sense of pride, self-esteem in Traveller identity so that their students gain more confidence in themselves both at school and in their day to day lived experience. TVG continue to work on broader education and training strategy into 2023 and beyond.

In line with TVG's values and principles, TVG continued to support the community in its fight for social justice and improved outcomes in accommodation, employment and health. TVG is an anti-racist organisation and cites structural and societal racism as the leading factor in health, accommodation, education, employment and mental health inequalities for Travellers. TVG appreciate all allies who stood with the Traveller community in the fight to anti-Traveller racism during 2022. We continue to look for solidarity from our settled community in Ireland and look to Government leaders to implement the many recommendations that have been researched and published regarding Traveller rights. The TVG continued to work with the Office of Children's Ombudsman, independent mediators and the Local Authority on their recommendations to improve living conditions on a local authority halting site in Cork.

In 2022 TVG continued to participate in the Traveller Inter-agency Group (TIG) with Directors from Local Authority including CEO and Deputy CEO, Cork ETB, Dept Social Protection, An Garda Siochana, Irish Defence Forces, Cork traveller Women's Network, Cork City Partnership and University College Cork. The group look at issues facing the Traveller community in Cork and look to collaborate between the various participating agencies, organisations and services to improve Traveller outcomes in Cork.

TVG continue to collaborate with the two universities in Cork, particularly in the field of Travelled education but also in areas of research, collaboration and training students in relevant fields such as nursing, town planning, social work and social studies to be culturally aware of the Traveller community's culture and potential barriers to service access and the most pressing issues facing the community so that they can best serve the community in their future careers. TVG continue to advocate for compulsory Traveller cultural awareness training for all public servants, especially in our teacher training colleges so that all people working in Ireland have a good understanding of Traveller culture, heritage

for the financial year ended 31 December 2022 and the current issues facing the community.

To round off a challenging period in TVG's history, we were delighted to be nominated and win a Pride of Place Award which we shared with our colleagues Cork Traveller Women's Network. The award celebrated the two organisation's resilience and long-standing work to represent and advocate for the Traveller Community in Cork City and beyond. The award noted that particularly during the Covid 19 pandemic TVG and CTWN were "invaluable inter-agency partners." It was an honour to be recognised for our work over the years and we will continue to advocate for Traveller rights in Cork city and beyond.

Financial Results

The surplus for the financial year after providing for depreciation amounted to €52,892 (2021 - €195,856).

At the end of the financial year, the company has assets of €1,284,233 (2021 - €1,210,012) and liabilities of €577,471 (2021 - €556,142). The net assets of the company have increased by €52,892.

Accounting Records

To ensure that adequate accounting records are kept in accordance with sections 281 to 285 of the Companies Act 2014, the directors have established appropriate books to adequately record the transactions of the company. The directors also ensure that the company retains the source documentation for these transactions. The accounting records are maintained at the company's office at 25 Lower John Street, Cork.

INDEPENDENT AUDITOR'S REPORT

to the Members of Traveller Visibility Group CLG

Report on the audit of the financial statements

Opinion

We have audited the financial statements of Traveller Visibility Group CLG ('the company') for the financial year ended 31 December 2022 which comprise the Income and Expenditure Account, the Balance Sheet, the Reconciliation of Members' Funds, the Cash Flow Statement and the related notes to the financial statements, including the summary of significant accounting policies set out in note 2. The financial reporting framework that has been applied in their preparation is Irish Law and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued in the United Kingdom by the Financial Reporting Council.

In our opinion the financial statements:

- give a true and fair view of the assets, liabilities and financial position of the company as at 31 December 2022 and of its surplus for the financial year then ended;
- have been properly prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland"; and
- have been properly prepared in accordance with the requirements of the Companies Act 2014.

Basis for opinion

NOTES TO THE FINANCIAL STATEMENTS

for the financial year ended 31 December 2022

1. General Information

Traveller Visibility Group CLG is a company limited by guarantee incorporated in the Republic of Ireland. The registered office of the company is 25 Lower John Street, Cork. The nature of the company's operations and its principal activities are set out in the Directors' Report. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

2. Summary of Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance

The financial statements of the company for the year ended 31 December 2022 have been prepared on the going concern basis and in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014.

Income

Income comprises grant and other funding received for the provision of services. Income is recognised when the services are carried out and the associated costs are incurred.

Tangible assets and depreciation

Tangible assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible assets, less their estimated residual value, over their expected useful lives as follows:

Land and buildings freehold	- 4% Straight line
Plant and machinery	- 20% Straight line
Fixtures and fittings	- 20% Straight line
Office Equipment	- 20% Straight line

The carrying values of tangible fixed assets are reviewed annually for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

Trade and other creditors

Trade and other creditors are initially recognised at fair value and thereafter stated at amortised cost using the effective interest rate method, unless the effect of discounting would be immaterial, in which case they are stated at cost.

Employee benefits

The company operates a defined contribution pension scheme. The assets of the scheme are held separately from those of the company in an independently administered fund.

Taxation and deferred taxation

The company has Charitable Status and is therefore exempt from Corporation tax.

Government grants

Capital grants received and receivable are treated as deferred income and amortised to the Income and Expenditure Account annually over the useful economic life of the asset to which it relates.

3. Departure from Companies Act 2014 Presentation

The directors have elected to present an Income and Expenditure Account instead of a Profit and Loss Account in these financial statements as this company is a not-for-profit entity.

4. Provisions Available for Audits of Small Entities

In common with many other businesses of our size and nature, we use our auditors to prepare and submit tax returns to the Revenue and to assist with the preparation of the financial statements.

11. Status

The liability of the members is limited.

Every member of the company undertakes to contribute to the assets of the company in the event of its being wound up while they are members, or within one year thereafter, for the payment of the debts and liabilities of the company contracted before they ceased to be members, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributors among themselves, such amount as may be required, not exceeding € 2.

12. Capital commitments

The company had no material capital commitments at the financial year-ended 31 December 2022.

13. Financial Reserve Policy

The Traveller Visibility Group (TVG) has a responsibility to provide Traveller community development projects to Travellers living in Cork. TVG receives funding from a number of a public sources each year and is reliant on this continued annual public funding in order to operate.

TVG Board of Management, through its HR and Finance Sub Committee have developed a Reserve Policy. This policy aims to ensure the sustainability of the organisation in the event of unexpected costs or loss of funding, unexpected costs or events so that it can continue to deliver services, meet its commitments and undertake work. At present this Reserve is set at €150,000 and is held in a separate TVG bank account. The Reserve sum will cover approximately 3 months salaries and running costs.

Traveller Visibility Group Board of Management will continue to review this reserve to ensure the financial stability of the organisation. The Board of Management actively seek to diversify funding streams so as to be less dependent on any one public funder.
